Notes from last meeting: the meeting looked at Dementia Care in Westminster. Notes from the meeting are available here, or via the Networks section on the One Westminster website, where you will also find the presentation slides http://www.onewestminster.org.uk/older-peoples-network

- 1. Sheila Drexler, one of the counsellors from Woman's Trust, gave a very powerful presentation about domestic abuse and the work WT does to help women recover from it. The full presentation is available here. Discussion points included the need for staff to be aware of the possibility of domestic abuse (current and/or in the past) when they are meeting older people and carers the need therefore for staff training and DA policy within our organisations.
- 2. Concia Albert from One Westminster gave a presentation on Social Prescribing which is available <u>here</u>. There was discussion about the proposed 4 hubs (Primary Care Networks or PCNs) for Westminster GP services, which will include social prescribing funded posts, but no money to follow the patient to the VCS or other provider. GPs will essentially be running primary healthcare services within each locality in Westminster these are Regents Park/Paddington; St John's Wood/Maida Vale; South Westminster; West End & Marylebone. CCGs will merge to become much larger overseers.
